The Lutie R-VI School District received confirmation from the Ozark County Health Department on September 2, 2020, that a staff member has tested positive for COVID-19. We are following the guidelines from the health department. The district cannot release the name of the staff member.

The Ozark County Health Department conducts contact tracing and will contact anyone at high risk of exposure. The health department has information on their Facebook page concerning the process for contract tracing. If you are contacted by the health department, please follow their recommendations.

If you are not contacted by the Ozark County Health Department, you are considered to be at low risk for contracting COVID-19. We ask that you still monitor your child for symptoms, which can include:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea
- Rash in children

Per our reopening plan, we will close the school Thursday, September 3, 2020 and Friday, September 4, 2020. Teachers will be available to help students via phone calls, emails, or Google Classroom. Please do not hesitate to contact your child's teacher for academic guidance.
